CERTIFICATE OF INCORPORATION

OF

ADIRONDACK SWIMMING, INC.

Under Section 402 of the Not-For-Profit
Corporation Law

IT IS HEREBY CERTIFIED, that,

A822957

(1). The name of the proposed corporation is Adirondack Swimming, Inc.

(2). The corporation is a corporation as defined in subparagraph (a) of Section 102 of the Not-For-Profit Corporation Law in that it is not formed for pecuniary profit or financial gain, and no part of the assets, income or profit of the corporation is distributable to, or enures to the benefit of its members, directors, or officers or to any private person except to the extent permissible under the Not-For-Profit Corporation Law.

(3). The purpose or purposes for which the corporation is formed are as follows, to wit:

(a). To promote interest in and encourage the development of swimming and diving skills and to promote the principles of water safety among the youth of the community, and in furtherance of such purposes to instruct and train the youth of the community in

swimming, water safety and diving and to conduct competitive swimming and diving programs among children of high school and elementary school age.

(b). To do any other act or thing incidental or in connection with the foregoing purposes, or in the advancement thereof, it being intended that this corporation be organized and operated exclusively for the purposes above stated.

As a means of accomplishing the foregoing purposes, the corporation shall have all the powers set forth in Section 202 of the Not-For-Profit Corporation Law of the State of New York, and, in general, to exercise such powers which are now or hereafter may be conferred by law upon a corporation organized for the purposes set forth herein, but not for pecuniary profit or financial gain of its members, directors, or officers except as permitted under Article 5 of the Not-For-Profit Corporation Law.

Nothing herein contained shall permit this corporation to carry on any of the activities contained in ~~Section 747 of the Executive Law or in~~ Section 404 of the Not-For-Profit Corporation Law of the State of New York.

(4). The corporation is a Type A corporation as defined in Paragraph (b) of Section 201 (Purposes) of the Not-For-Profit Corporation Law.

(5). The offices of the corporation shall be located in the Town of Bethlehem, County of Albany, State of New York.


(6). The territory in which the corporation's activities will principally be conducted is the County of Albany, State of New York.




